Use of All Weather Equestrian Arena – Oxford A&P Showgrounds

Condition of Use:

1. Riders must follow all practical safety requirements – eg checking arena before use, wearing of suitable riding helmets (Yellow Tagged), and any other accepted equestrian practice.
2. Any damage to the area to be reported to the A&P Executive Officer or Donna Coster within 24 hours.
3. All persons entering the grounds must comply with WorkSafe NZ.
4. You are 18 years of age or over.
5. When using the grounds, you are to have another person in attendance, or at the very least have someone knowing your whereabouts and what time you are expected to return.
6. Entry to the showgrounds to be Church Street – **Church Street gate to be kept shut at all times.**
7. Vehicle Driver when travelling through grounds, must be vigilant of other users, including children from the neighbouring school.
8. Arena's Gate Padlock number is available from Donna Coster - **Arena Gate to be locked at end of use.**
9. Oxford A&P Association, Committee or its Members will not be liable for any unfortunate event that may occur to you, your horse/pony or property on the grounds.
10. Any damage to Oxford A&P Association's grounds including arenas and/or property by hirer, will be repaired at the hirer's cost.
11. Changes to Conditions – If at any stage of the user period, conditions are identified that could affect the property of the A&P Association or the Health & Safety of those in attendance, the hirer will take all reasonably practical actions to remedy the situation and will communicate those changes to the Executive Officer, as soon as possible.
12. Please Note: That the arena may be in use by other uses or organisations. Equestrian Events will be published, once known on the Associations website and/or Facebook page.
